THIS DOCUMENT IS REVIEWED BY THE EXECUTIVE COMMITTEE OF THE BOARD AND THEN USED BY THE EC TO DRAFT A COMPREHENSIVE PERFORMANCE EVALUATION BASED ON THE REPORTED RESULTS AND EC OBSERVATIONS. THE PERFORMANCE EVALUATION IS USED AS THE GAUGE FOR CEO COMPENSATION, I.E., COST OF LIVING INCREASES AND/OR BONUSES. EACH YEAR, THE CHAIR OF THE BOARD REVIEWS A PUBLISHED NATIONAL NON-PROFIT WAGE ANALYSIS FOR CEOS/EXECUTIVE DIRECTORS, AND SHARES IT WITH THE EXECUTIVE COMMITTEE TO ENSURE THAT CCEE IS WITHIN THE RANGE OF NATIONAL NORMS AND COMP RANGES. THE CEO'S YEAR END PERFORMANCE REVIEW IS CONDUCTED WITHIN THE FIRST QUARTER OF THE SUBSEQUENT FISCAL YEAR.
